Why Investors Use It

A Debt-Service Coverage Ratio (DSCR) loan lets you qualify on the property's rent, not your personal W-2s or tax returns. If the projected monthly rent covers the new mortgage payment, you're in business. Fast approvals, light documentation, zero DTI math.

General Guidelines

- › Close multiple properties at once
- › 1–10 unit properties with LTV up to 70%
- › Loans up to \$1.5 Million for 1-4 Unit Properties and up to \$2 Million for 5-10 Unit Properties
- › Cash-Out up to \$500,000 for 1-10 Unit Properties
- › No limit on the number of properties owned and you can finance up to 10 properties
- › Non-Warrantable condos and Condotels allowed (up to 75% LTV)
- › Qualify on Interest Only Payments - Great for qualification and cashflow purposes
